CONTINUATION ORDER

WHEREAS the recognition u/s 14(3)(a) of NCTE Act, 1993 was granted to the institution namely, ~~Viswa Vignan College of Education, 10/22, Gowrishankarapuram, Gudivada, Krishna District, Andhra Pradesh~~ run by ~~Sree Vidya Educational Society, Krishna District, Andhra Pradesh~~ vide Order No. F.SRO/NCTE/B.Ed/2006-2007/682 dtd. 12.04.2007 for conducting **B.Ed.** course of one-year duration with an annual intake of 100 students.

2. **AND WHEREAS**, after promulgation of NCTE Regulations, 2014, the institution by consented to come under new Regulations vide a notarized affidavit dated 22.01.2015 and the Revised Provisional Recognition Order (RPRO) was issued to the institution on 06.05.2015 for conducting **B.Ed.** programme of two years duration with an annual intake of 100 students (Two Basic Units) from the academic session 2015-2016.

3. **AND WHEREAS**, a Corrigendum was issued to the institution vide Order No. F.SRO/NCTE/APSO7148/B.Ed/AP/2015/72390 dtd. 07.08.2015 for reduction of intake from 2 units to 1 unit.

4. **AND WHEREAS**, the SRC in its 382nd Meeting held on 26th – 27th November, 2019 considered the matter and decided to withdraw the recognition. Accordingly, as per the decision of SRC, withdrawal Order No. F.SRO/NCTE/APSO7148/B.Ed./AP/2019/112798-2804 dtd. 09.12.2019 was issued the institution.

5. **AND WHEREAS**, the institution has submitted E-mail dated 26.02.2026 along with decision of the Hon'ble High Court of Andhra Pradesh Vide Order No. 31901 of 2025 dtd. 18.11.2025.

6. **AND WHEREAS**, against, the withdrawal order dated 09.12.2019 the institution has filed Writ Petition bearing No. 31901/2025 before Hon'ble High Court of Andhra Pradesh at Amaravati titled as "Viswa Vignan College of Education Versus NCTE & others" whereby the Hon'ble High Court vide Order dated 18.11.2025 set aside the impugned withdrawal order/s. The Operative part of the common order dated 18.11.2025 reads as under: -



“3. Hence, following the said common order passed by this Court in Writ Petition No. 26846 of 2024 and batch, dated 27.10.2025 and for the reasons mentioned therein, this Writ Petition is allowed and the impugned order withdrawing the recognition of the petitioner institution is set aside. However, it is needless to mention that the respondent-authorities are at liberty to issue letters to the petitioner institution to obtain information and process the same in accordance with law duly following the provisions of the NCTE Act, 1993. There shall be no order as to costs.

As a sequel thereto, the miscellaneous applications, if any, pending in this Writ Petition shall stand closed.”

7. **AND WHEREAS**, the SRC in its 490th Meeting held on 03rd March, 2026 considered the Court matter and decided to issued Restoration Order & Show Cause Notice. Accordingly, as per the decision of SRC, Restoration Order & Show Cause Notice was issued to the institution on 06.03.2026. The institution has submitted its reply dated 19.03.2026.

8. **AND WHEREAS**, the SRC in its 496th Meeting held on 12th – 13th May, 2025 considered the matter and decided as under:-

“The original file of the Institution along with other related documents, NCTE Act 1993, Regulations, Guidelines issued by NCTE from time to time, the SRC after careful consideration made the following observations: -

- 1. A Show Cause Notice dated 06.03.2026 was issued to the institution on the various grounds.*
- 2. The institution submitted its reply dated 19.03.2026 alongwith all required documents.*
- 3. The Committee perused the documents and found the same to be in order and as per NCTE Norms, Rules and Regulations.*

Keeping in view of the above the SRC decided as under: -

The Restoration Order already issued to the institution on 06.03.2026 stands continued.”

9. **NOW THEREFORE**, this order is issued permitting the institution i.e., **Viswa Vignan College of Education, Survey No. 10/22, Gowrishankarapuram, Gudivada, Krishna District-521301, Andhra Pradesh** for Continuation of recognition for **B.Ed. programme** for two years duration with an annual intake of **1 Basic Unit of 50 Students**.

10. Further, the institution is required to fulfil all such other requirements as may be prescribed by NCTE as well as other regulatory bodies like UGC, affiliating body/University, State Government concerned etc. as applicable.



11. The institution shall submit to the Regional Committee as Self – Appraisal Report at the end of each academic year along with the statement of annual accounts duly audited by a Chartered Accountant.

12. The institution shall maintain its Website with hyperlink to the Council and the Southern Regional Committee, covering, inter-alia, the details of the institution, its locations, name of the programme(s) with intake; available of physical infrastructure, such as land, building, office, classrooms, and other facilities of amenities; instructional facilities, such as laboratory and library and the particulars of their teaching faculty and non-teaching staff with photographs, for information of all concerned. The information with regard to the following shall also be made available on the website namely: -

- a. Sanctioned programme(s) along with annual intake in the institution:
- b. Name of faculty and staff in full as mentioned in school certificate along with their qualifications, scale of pay and photograph.
- c. Name of faculty members who left of joined during the last, quarter:
- d. Name of Students admitted during the current session along with qualification, Percentage of marks in the qualifying examination and in the entrance test, if any, date of admission, etc.
- e. Fee charged from students.
- f. Available infrastructural facilities.
- g. Facilities added during the last quarter.
- h. Number of books in the library, journals subscribed to and additions, if any, in the last quarter.
- i. The affidavit with enclosure submitted along with application.
- j. The institution shall be free to post additional relevant information if it so desires.
- k. Any false or incomplete information on website shall render the institution liable for withdrawal of recognition.

13. The institution shall adhere to the mandatory disclosure in the prescribed format and display up-to-date information on its official website.

14. The institution shall make available the list of students admitted on its official website.

15. The institution shall fill the information on GIS Portal on the NCTE Website.

If the institution contravenes any of the above conditions or the provision of the NCTE Act, Rules, Regulations and orders made of issued there under, the institution will render itself vulnerable to adverse action including withdrawal of recognition by the Southern Regional Committee under the provisional of Section 17(1) of the NCTE Act, 1993.

Also order that a copy of this Order be published in the official Gazette.
